
Virtual meetings — wider participation

Greetings Compatriots. I hope you've had a relaxing and pleasant summer, and are anxiously awaiting Fall; already I see leaves falling!

I can hardly believe that I'm already in the sixth month of my Presidency. I have

certainly appreciated the opportunity to be of service to the South Carolina Society of the Sons of the American Revolution, and I look forward to a productive second half of my one year term. I think it will be interesting and unique.



The COVID-19 virus continues to hamper our ability to conduct State Society and Chapter meetings, as well as commemorations. Nonetheless, we managed to conduct our first ever virtual electronic meeting at our last Board of Governors (BOG) meeting on July 25. There were a few hiccups and lost connections, but generally we were able to use an online platform as an informational meeting, and we were able to also achieve a quorum to conduct the meeting.

Those are gigantic steps forward. Our next Board of Governors Meeting is scheduled for Oct. 17. At this time, we are uncertain if we will attempt to have again only an online electronic meeting, or a physical face to face meeting at Shandon United Methodist Church, or a combination of both. Our decision, of course, will hinge on COVID-19 meeting recommendations at that time.

One thing we do know is that, if we

have our traditional physical meeting, we will attempt to simultaneously live stream the meeting so that members unable to attend would be able to view it on their home computers. We would afterwards post it to our website.

In fact, the Executive Committee feels we need to plan on having permanent virtual footprint to include those unable to come to all future meetings or commemorations—this is actually one good benefit of the COVID-19 pandemic, if there in fact can be anything good! But the truth is that the pandemic has forced organizations to think outside the box, and ours is no exception. There is alternative technology that can enable wider participation and greater accessibility—for now, it will never fully take the place of our physical face to face meetings, but will complement our gatherings.

The Battle of Eutaw Springs Chapter completed its annual commemoration Sept. 5. This commemoration has gained

239th Anniversary Battle of Eutaw Springs

On Saturday, Sept. 5, the Battle of Eutaw Springs Chapter hosted a mixed live and virtual commemoration at the battle monument park in the Eutaw Springs community of eastern Qrangeburg County.

Due to pandemic concerns, there had been discussion on

the state and local chapter levels as to if a program should be held at all this year. With careful planning, it was decided that the usual two day commemoration would be scaled back to just a wreath laying ceremony with a speaker.

The focus was to have a commemoration honoring the Patriots who fought and died at the battle, would be worthy of being a National SAR event and to do this in the time frame of

one hour. The consensus of the participants was that the event met these expectations.

Twenty-three wreaths were presented in person. Five wreaths were submitted virtually. Participants included SAR chapters from South Carolina, Georgia, North Carolina, Maryland and Florida. DAR chapter participants were from South Carolina, North Carolina, Georgia and Florida. Children of the American Revolution participants were from South Carolina and a national C.A.R. officer submitted a virtual representation. Other representation came from the

Sons of the Revolution, Calhoun County Museum and Cultural Center, and the family of Patriot Elijah Ivey.

SCSSAR State President James Wyrosdick was unable to attend due to health issues and Senior Vice President David Smith, along with Battle of Eutaw Springs Chapter

President Ewart Irick, presided over the event. A color guard detail composed of SAR members from South Carolina, Georgia and including the SAR National Color Guard Commander, Louis Raborg Jr., posted and retired the colors.

David Reuwer, Battle of Eutaw Springs historian, delivered a powerful address on the importance of the battle. The South Carolina

Battleground Preservation Trust cannon team opened and closed the commemoration with a cannon volley, much to the crowd's enjoyment.

The commemoration was recorded, and a video of the program, after editing, including all virtual submissions, will be posted on the SCSSAR state website (SCSSAR.org) and on Facebook at a later date. *Doug Doster.*

Society of the Sons of the American Sons of the American Revolution (NSSAR).

The Battle of Eutaw Springs Chapter planners were not able to live stream the event due to the signal weakness in the remote location; however, the event was recorded, and presenters were able to participate, either physically, as the event was held live, or they could send an electronic or online picture of themselves or group to be added later into the actual video recording of the event.

This is the wave of the future—being virtually present as opposed to actual face to face. But it does present some interesting dilemmas. For example, should someone, let's say from Oregon, be allowed to claim credit for presenting a wreath at a ceremony in South Carolina merely by sending a photograph, or video? And would such a policy of allowing a photograph or video to take the place of coming to a meeting, actually discourage people from wanting to come to the meeting?

These are questions that can only be resolved over time and through experience. But one thing is for certain—things after COVID-19, whenever that comes, will never be the same.

SCSSAR realizes things will not be the same, and we've invested in buying an electronic camera to be used in live streaming at State and Chapter meetings, and commemorations and other events. We may have some logistical challenges insofar as getting the camera from one place to another, or one person to another, but we'll work out some solution. If a Chapter would like to borrow the camera to live stream or record an event, let me know.

On a different front, our State Secretary, Compatriot Guy Higgins, is intently working on emailing out dues notices in October. He has attempted to update email addresses, but if you should not receive a notice, let me know.

All SCSSAR members should strive to establish and maintain an email address, in this electronic day and age. You may dismiss this urging as mere pandering to modernists, but they said the same thing about the horse and car—cars would never take the place of horses—now there is not

a single horse to be found on roads hardly anywhere!

And computers are the same—the electronic ability to communicate (email) has greatly expanded and has "virtually" overtaken the Postal Service. A sacrosanct government service steeped in American History!

I understand that we have approximately 300 members out of 850 who do not have email addresses. Folks, you've got to get access to email—maybe through a grand-daughter or grandson—it is simply vital, and too cost effective for our State Society.

Every notice that is mailed with traditional mail, costs about \$1, if you consider the cost of a postage stamp, envelope, and labor to address, generate a copy of a dues notice to send, fold it to place in the envelope, seal the envelope, and then, most probably, physically take them to a Post Office for mailing.

I leave you with three challenges: make sure you have an updated email address on file with the SCSSAR, become active with a Chapter or with your Chapter, and complete an application for membership on someone. Take care, and God Bless!



Cambridge Chapter Makes JROTC Awards for Outstanding Cadets

Once is impressive; twice is outstanding; but when the Vikings of Emerald High School Air Force JROTC win the South Carolina SAR Society Enhanced Award for JROTC the third time in a row — it is almost beyond words. Cadet Captain Elijah Peterson, with guidance by Senior Air Science Instructor Major David Pfancook, USAF (Retired), made it happen.

The SAR Enhanced Award consists of a certificate, neck ribbon with silver medallion and a cash award of \$700. Cadet Peterson also received the Cambridge Chapter Bronze Award for his accomplishment in his Unit. He has served the Vikings as Drill Team Commander, Saber Team Commander and Color Guard Commander.

The Chapter-level Bronze Award was made on nomination of Major Pfancook and his staff. The state-level award is a competitive event that requires a written essay on the subject of how JROTC helps a cadet become a better citizen of the United



Compatriot Robert Escue, Genealogist of the Godfrey Dreher Chapter, started in April transferring the information of more than 200 compatriots to the SAR Patriot Research System (PRS).

The PRS is a database combination of the previous SAR Patriot Record Index, the SAR Revolutionary War Graves Registry, and information from the SAR Patriot Index CD (2002), plus additional information and updates from various state grave registry databases and patriot biographical sketches submitted to tell the story of our patriot ancestors.

Several compatriots of the SCSSAR have volunteered to assist in transferring information from compatriot applications into the PRS database.


Robert Escue primarily worked on records of the Godfrey Dreher, Col. Thomas Taylor, and Maj. General William Moultrie Chapters. He indicates that most of the records for SCSSAR Chapters have now been completed. He plans now to start assisting with other state societies.

The PRS database with the addition of the information from applications will

have greatly enhanced value to genealogist researchers. We congratulate Compatriot Escue on his service to the SAR. He will be recognized by the National SAR with the Lafayette Medal and certificate.

History.com. Aug. 27, 1776: During the American Revolution, British forces under General William Howe defeat Patriot forces under General George Washington at the Battle of Brooklyn (also known as the Battle of Long Island) in New York.

On August 22, Howe's large army landed on Long Island, hoping to capture New York City and gain control of the Hudson River, a victory that would divide the rebellious colonies in half. On August 27, the Red Coats marched against the Patriot position at Brooklyn Heights, overcoming the Americans at Gowanus Pass and then outflanking the entire Continental Army. Howe failed to follow the advice of his subordinates and storm the redoubts at Brooklyn Heights, and on August 29 General Washington ordered a brilliant retreat to Manhattan by boat, thus saving the Continental Army from capture.

Godfrey Dreher Chapter conducts virtual chapter meeting

The Godfrey Dreher Chapter conducted their first virtual teleconference chapter meeting via the online Zoom application, the evening of Aug. 27. We believe our chapter meeting may have been the first virtual chapter meeting in the South Carolina Society

The SCSSAR had conducted a virtual Board of Governors meeting earlier in the month.

This meeting, however, had a slightly different technology infrastructure. In addition to incorporating the Zoom virtual meeting application, the chapter's vice president of technology, Keith Maddox, also successfully, connected a video camera/recorder and screen projection system to the virtual Zoom application for both Zoom broadcasting the meeting and video recording the meeting.

This creative meeting technology infrastructure proved that the chapter could conduct hybrid virtual chapter meetings in the future. By definition, a hybrid meeting would consist of both on site meeting attendees and those in self quarantine because of a lingering virus threat. In addition, this same infrastructure will allow meeting attendees who are medically inca-

July 25 Board of Governors Minutes

Call to Order: President Jim Wyrosdick called the meeting to order at 10:04 a.m.

Invocation: Chaplain Lawrence Peebles gave the invocation.

Posting of the Colors: Color Guard Commander Dan Woodruff.

Pledge of Allegiance: Led by David Smith.

Salute to the South Carolina Flag: Led by Thomas Blackmon.

Sons of the American Revolution Pledge led by Thomas Blackmon.

Roll Call: Recording Secretary Ronny Powell called the roll and established a quorum.

New Business or House Keeping, Specifically for the First Electronic Meeting:

President Wyrosdick requested Chapter President Jonathan Kiser present a motion to approve the standing rules that each attending member should have been mailed.

Motion made by Compatriot Kiser and seconded by Douglas Doster: "I move that we approve with unanimous consent the standing rules that were previously sent to the members of the Board of Governors with two additions as an amendment, one being that we limit individual speaking to three minutes and also that once you have spoken on a particular topic that everyone else who wishes to speak on that topic be given that opportunity to speak before you are given a second chance to speak."

Discussion ensured, and the motion carried unanimously without change.

Approval of Minutes:

Compatriot Powell moved at the request of President Wyrosdick that the minutes of the January BOG meeting be approved. Before a second was made, discussion took place about the minutes not having been published on the web site, and several attendees were not in receipt of the minutes through email. Compatriot Higgins seconded the original motion.

Then, during discussion, the motion went from being tabled to postponed. Compatriot Woody Carothers moved for postponement, and Compatriot Bill Wilson seconded the motion to postpone the approval of the January minutes until the next BOG meeting, and after we have them posted to the web site for all to review. Without ob-

jections, the motion carried unanimously.

Report Package:

Acceptance of officer, chapter and committee chairman reports was postponed until everyone receives an email copy prior to the next BOG.

Old Business:

Thomas Blackmon gave a report on our strategic planning initiatives: We were going to have a two-fold strategic planning initiative, one focusing on member engagement, where we were going to look at recruiting compatriots that are in the SAR, but are not members of the South Carolina society.

They are either living in South Carolina or in a contiguous border state. So we should be looking for both possibilities, the transfer of membership or an application for dual membership. And this was going to roughly account for about maybe 200 or so compatriots.

We were given the authorization to proceed with Phase 1 and 2. We were trying to have our compatriots associated with a chapter nearest to their physical address. That list was based off of a service area map that did not account for some of our newest chapters. So that had to be reviewed by Compatriot Higgins along with our regional vice presidents in March.

The COVID-19 pandemic set in and that created a series of challenges, first and foremost, our National headquarters shut down operations. So if we had initiated this contact, these compatriots would not have had a dual membership or a transfer of membership form processed.

Since we are meeting digitally, we are finding ourselves asking the question, if we make contact with these members, what exactly can we offer them in terms of participation? I think it would be more prudent to temporarily suspend the initiative so we can focus on membership retention. Once we start re-engaging in meetings and commemorations, then we will be able to go forward and engage in our mission statements.

I'm encouraging chapters to meet digitally and maybe through newsletters. I had a reply from one of our committee members. Compatriot Griffin told me some of the great things that the Midlands region is doing in terms of connecting online, which is very encouraging.

We discussed in the EXCOMM Committee about Recording Secretary Powell and Secretary Higgins establishing a form that will explain what our chapters are in-

tending to do and what they have done in the past. A lot of chapters are meeting all of our goals already in terms of our Mission Outreach commemorations.

In the coming week or so, I'm going to be reissuing some of our explanations about our youth programs. I'm will also bolster our speakers list and resubmit.

New Business

President Wyrosdick will be forming an ad hoc committee of regional vice presidents to contact their at-large members and to report quarterly the results of their contact to State Secretary Higgins. Extensive discussion took place on the "yellow" and "blue" national databases and their use.

Announcements

- 1. We are proposing a Color Guard manual, a State Officers handbook manual, and Protocol manual. These are to be published on the website.
- 2. We are in the process of chartering a new chapter in the Florence area. State Secretary Guy Higgins is spearheading that effort.
- 3. We are currently negotiating with Salesforce, a company that helps businesses develop websites. We are hoping to establish a nonprofit status with them, and we will give further information as that develops. We are working on a memorandum of understanding with our current website administrator. He is a graduating student at Clemson University. He has been hospitalized, and he's not able to do things right now. We need to get a written agreement with him that will be presented to our Executive Committee and then to the BOG for approval.
- 4. Chapter President Matthew Breen presented information about having a statue to Brig. Gen. Isaac Huger placed in a new Revolutionary War Park on public land.
- 5. President Wyrosdick is forming an ad hoc members benefit committee with Thomas Blackmon as chairman. It will make a presentation at our next special video meeting.

How to submit items to The Palmetto Patriot

Keep articles as short as possible while still telling the story. Send articles in Microsoft Word format to Tom.Hanson@HansonCommunications.org

Send digital photographs as attachments and not embedded into the Word document.

Make sure you images are high resolution, at least 200 DPI, and that no time or date stamps appear in the images.

Limit the number of photographs to those you would like most to appear in the publication.

In group shots, have participants drop their hands to their sides to avoid fig leaf poses.

When taking photos at meetings, get as close to the speaker as possible, and avoid shooting the backs of audience heads.

From Eric Barnhill, Gen. Andrew Pickens Chapter: Fill the frame with the subject, unless you are trying to capture a large area (monument, battlefield). Better to get head shots than feet shots. Choose your background carefully. Often it just takes a minute to look around and find a more appropriate background. Watch your lighting. Better to have subjects face the lights (sun for outdoor shots) and be careful of indoor lights, your camera may set the exposure for lights if they are in the shots. Articles are always more interesting when pictures accompany them. Take lots of digital pictures and choose the ones that best capture the subject. Check your spelling, spell check sometimes makes words you don't want.


