### Moving our Society to the next milestone


#### **By James Wyrosdick** SCSSAR President

I would like to express my thanks and appreciation to members of the South Carolina Society for their confidence in my ability to fulfill the duties of president. I will most certainly need the assistance of all.

Compatriots, as I embark on this mis-

sion, you can be sure, I will be calling on you! We are in unprecedented challenging and times with a pandemic that is causing us to adjust meeting and event protocols.

I would also like to express my deep appreciation to immediate past-



President, compatriot Nathan Kaminski, for his guidance, leadership and direction in the past year to our State Society. I hope to replicate his successful tenure and build upon the strong foundation he laid, particularly in development of the strategic planning initiative.

My goals for the upcoming year are threefold: First, increase membership by 10 percent; second, continue the strategic initiative begun last year by past-President Nat Kaminski; and lastly, make a goal of personally contacting each South Carolina State Society member during the year, either by seeing them at a commemoration; event; a chapter meeting; or contacting them by telephone.

We currently have about 850 members, which means that I will have to average at least two or three daily contacts. Also, in this regard, we have life members that we need to reestablish contact, and I, along

with our Senior Vice President, who chairs membership retention, will develop a plan to contact them.

I intend to make as many chapter meetings as possible-my home in Orangeburg enjoys a central location in the state, and most areas are accessible within a few hours. I enjoyed attending the Gov. Paul Hamilton Chapter installation ceremony last December at Dataw Island, outside of Beaufort. Also, I represented the South Carolina SAR Society, at the C.A.R. annual meeting at Hickory Knob State Park in February.

I am looking forward to getting out more, depending on, of course, meeting restrictions and social distancing. We may have to resort to virtual online meetings and commemorations-we will have to adjust to whatever limitations that conditions might impose, i.e. stay at home orders.

But one area we can all continue to work on, largely at home, is the area of membership. I challenge each of our 850 members to complete at least one set of application papers on a new member. You've got the time, interest, like a challenge, and probably have a desire to expand your knowledge and use your mind-all prerequisites for application

Preparation. Mark your calendars now for our planned Board of Governors meetings: July 25, Oct. 17, and Jan. 23. If you've never attended a Board of Governors meeting, this year is your chance! All these dates fall on a Saturday, the meetings start at 10 a.m., and all are held at Shandon United Methodist Church on Devine Street in Columbia. A buffet lunch is served afterwards, for a nominal cost of \$10. The BOG meeting is where the state society business takes place, and is an excellent vehicle to learn about issues directly affecting your local chapter, as well as your individual membership. 

### Honoring Purple Hearts Across County Initiative Recognizes Recipients' Service and Sacrifice

The Maj. Robert Crawford chapter of the Sons of the American Revolution (SAR), based in Indian Land, began a Purple Heart Initiative in late 2018, following research conducted by chapter President John Marker.

The program brings recognition to individuals who have served and sacrificed for their country, along with a special designation to the city or county where these veterans live.

In December 2018, the Lancaster County Council passed a formal proclamation designating our county as an official Purple Heart County.

The county received a 24-by-18-inch canvas print commemorating the proclamation and paying tribute to those who have received the Purple Heart award for their service.

The canvas print displays the original transcribed text from Gen. George Washington's Aug. 7, 1782, general order for the Badge of Military Merit (now known as the Purple Heart):

"The Purple Heart is the oldest military decoration in present use and was initially created as the Badge of Military Merit by General George Washington on August 7, 1782. It was made available to the common soldier and is specifically awarded to members of the United States Armed Forces who have been wounded or paid the ultimate sacrifice in Combat with a declared enemy of the United States of America."

The original Badge of Merit was a heart embroidered on purple cloth. Following World War I, the medal, which is still used

Please send digital photographs as attachments and not embedded into a Word document. today, was designed by Elizabeth Will at the request of Gen. Douglas MacArthur, who revived the award.

This medal, featuring a profile and bust of George Washington, was introduced on the 200th anniversary of Washington's birth on Feb. 22, 1932.

It was initially awarded only to Army soldiers, but a 1942 presidential order expanded the Purple Heart to honor those in other branches. After World War II, the Purple Heart was awarded to only those wounded or killed in combat.

Since the official county proclamation, Marker coordinated with Lancaster County Veterans Affairs Officer Robin Ghent to buy and install 15 road signs at major entry points into Lancaster County, marking the county's designation as a Purple Heart County.

"Robin helped us get funding for the signs through the County Council, and arrange for their installation, too," Marker said.

In addition to the road sign project, all county residents who have earned a Purple Heart are qualified to be personally recognized for their service and to receive a 14-by-11-inch poster, two coasters and two poker chips featuring the Purple Heart symbol.

So far, 13 Purple Heart recipients who live in Lancaster County have been honored. They include Bob Barth, Thom Cook, Neil Grace, Mitchel Kotula, Mitchel Kotu-

#### How to submit items to The Palmetto Patriot

*The Palmetto Patriot* welcomes articles and photos from compatriots in the South Carolina Society.

Here are some pointers.

Keep articles as short as possible while still telling the story. Send articles in Microsoft Word format to Tom.Hanson@HansonCommunications.org

Send digital photographs as attachments and not embedded into the Word document.

Make sure you images are high resolution, at least 200 DPI, and that no time or date stamps appear in the images.

Limit the number of photographs to those you would like most to appear in the publication.

In group shots, have participants drop their hands to their sides to avoid fig leaf poses.

When taking photos at meetings, get as close to the speaker as possible, and avoid shooting the backs of audience heads.

From Eric Barnhill, Gen. Andrew Pickens Chapter: Fill the frame with the subject, unless you are trying to capture a large area (monument, battlefield). Better to get head shots than feet shots. Choose your background carefully. Often it just takes a minute to look around and find a more appropriate background. Watch your lighting. Better to have subjects face the lights (sun for outdoor shots) and be careful of indoor lights, your camera may set the exposure for lights if they are in the shots. Articles are always more interesting when pictures accompany them. Take lots of digital pictures and choose the ones that best capture the subject. Check your spelling, spell check sometimes makes words you don't want.




Since the 1777 Flag Resolution, our nation's flag has been a beacon of hope that the principles of life, liberty and the pursuit of happiness will endure.
