250 years ago the course of American history was forever changed

As 2019 draws to a close, I want to give a hearty "thank-you" to the many Compatriots in our Society who have worked tirelessly this year to promote public

awareness of the principals underlying the founding of the United States and the institutions of American freedom.

The annual commemorations (I counted 15 major events conducted by our Chapters around the state each year), the



various grave-markings faithfully held and conducted, and our ongoing effort to expand our youth education programs are examples of how the Society helps perpetuate the accounts of patriotism, courage, sacrifice, tragedy and triumph of the persons who supported and effected the independence of the American people.

I recently attended an event that thoroughly impressed upon me the need to stay focused on these SAR goals. This was a kick-off celebration by the Governor, the South Carolina Battleground Trust, the American Battlefield Trust, the S.C. Conservation Bank, the National Park Service, and the S.C. American Revolution Sestercentennial Commission, underscoring the effort to plan and execute observances around the State marking the 250th anniversary of the Revolution, as well as preserve and mark hallowed Revolutionary War battle sites.

This point was underscored: "250 years ago, the course of American history was forever changed by events that unfolded across South Carolina. In the Revolutionary War's other theaters of combat - New England, the Middle Colonies of New York, New Jersey and Pennsylvania — the cause of liberty balanced on a knife's edge. It was the Southern Campaign that kept the spark of Revolution alive.

"Yet, few people today know or appreciate the determinative role of the Palmetto State in winning the American war for independence. We believe that will change in the coming years, thanks to a confluence of programs designed to shed light on this important chapter in American history."

In the next several years, our South Carolina Society, along with other major lineage organizations such as the DAR, will play an integral role in this extensive effort to raise public awareness, promote patriotism, and recognize the true value of American democracy. Although this is something our Society already does every year, we must learn to do it better and in ways that capture the public's imagination.

The National SAR has established the 250th Anniversary of the American Revolutionary War Committee. This committee at the national/federal level will publicize the anniversary using media, education and government contacts and help develop educational programs and booklets relating to the American Revolution. We have three of our South Carolina compatriots serving on this committee (Dan Woodruff, Greg Ohanesian and Guy Higgins).

The National Committee has asked each state SAR to establish a counterpart State committee that can liaison with it and work within each state to facilitate planning appropriate commemorations of these upcoming historic events. The SC Society has now established an ad hoc 250th Anniversary Planning Committee. If you would like to participate as a member of this committee in this interesting and important work, please let me know!

As one writer put it: "A generation which ignores history has no past and no future." It is our duty as members of the SAR to ensure that our generation and those that follow understand our past so

2020 Annual Meeting set for March 27-28 in Clinton

Battle of Eutaw Springs commemoration designated a National Event

At the Fall Leadership Conference in Louisville, the National Society's Historic Sites Committee approved our application for the Battle of Eutaw Springs commemoration to be designated a National Event. This means that the SAR now recognizes four battles fought is South Carolina as among the most important commemorations across the country (Eutaw Springs, Waxhaws/Buford's Massacre, Kings Mountain and Cowpens). Congratulations to Doug Doster and the Compatriots of the Battle of Eutaw Springs Chapter. All the hard work they have been doing for years to perfect this event is being recognized at the National level.

Nearly three months after the Treaty of Paris was signed ending the American Revolution, the last British soldiers withdraw from New York City, their last military position in the United States. After the last Red Coat departed New York, Patriot General George Washington entered the city in triumph to the cheers of New Yorkers. The city was captured by the British in September 1776 and remained in their hands until 1783.

Four months after New York was returned to the victorious Patriots, the city was declared to be the capital of the United States. It was the site in 1789 of Washington's inauguration as the first U.S. president and remained the nation's capital until 1790, when Philadelphia became the second capital of the United States under the U.S. Constitution. A Compatriot Grave Marking Ceremony Honoring a Co-Founder of the South Carolina Society, Sons of the American Revolution and its First President South Carolina Gov. John Peter Richardson III Sept. 25,1829 to July 6, 1899

CAMDEN — A Grave Marking Ceremony to honor John Peter Richardson III, a co-founder of the South Carolina Society Sons of the American Revolution and its First President, took place Nov. 2 in the front yard of the Old Quaker Cemetery in Camden.

Participants included Compatriots and men forming a new chapter in Florence, the Compatriots and men revitalizing the Col. Joseph Kershaw Chapter in Camden, the Compatriots of the Col. Matthew Singleton Chapter in Sumter, the Compatriots of the Col. Thomas Taylor Chapter in Columbia, and the Compatriots of the Godfrey Dreher Chapter in Lexington.

Other State Societies were represented by Tim Massey, President of the Watauga Chapter in Tennessee, Jim Wood Past President of the Mecklenburg Chapter in North Carolina, and Ed Rigel Sr., Past President of the Lyman Hall Chapter in Georgia.

The Daughters of the American Revolution were represented by Sharon Satt-terthwaite, Past Chaplain of the Nathanael Greene Chapter in South Carolina, Ann Jenkins of the Samuel Bacon Chapter in South Carolina, Gena Bobo, Treasurer of the Elizabeth Hutchinson Chapter in South Carolina, and Melodie Daniels of the John Sevier – Sarah Hawkins Chapter in Tennessee.

The Children of the American Revolution were represented by Gabe Bobo, National Assistant Registrar, J Bobo, South Carolina Second Vice President, Gray Bobo, President of the Martha Bratton Society in South Carolina, Ivan Daniels, Tennessee State Chaplain, and Cohen Daniels, Tennessee President Fort Watauga Society in Tennessee.

Founding of the South Carolina Society, Sons of the American Revolution

On April 18, 1889 25 men met in the State House in Columbia, South Carolina, to consider forming a state society dedicated to perpetuating the patriotic ideals that had led to the American Revolution and the founding of the United States of America.

This meeting was called in response to an invitation from a special committee of the Society of the Sons of the Revolution of New Jersey to attend a meeting on April 30, 1889 (as a part of the centennial celebration of George Washington's inauguration as our first President) at the Fraunces Tavern in New York City.

That day the men decided in favor of the formation of the state society and organized it by appointing officers (including delegates to attend the meeting in New York City). South Carolina Gov. John Peter Richardson III, was appointed the first President of the South Carolina Society.

At the New York City meeting the National Society Sons of the American Revolution was formed, and the South Carolina Society was one of the 11 State Societies who had organized prior to and supported the organization of the National Society.


Gov. John Peter Richardson III

John Peter Richardson III was the 83rd Governor of South Carolina, from 1886 to 1890. It was during his term of Governor that the South Carolina Society SAR was founded and he was appointed its first President.

Richardson was born in Clarendon County, South Carolina, to John Peter Richardson II, a former Governor of South Carolina, and Juliana Augusta Manning. After graduating from South Carolina College in 1849, Richardson managed Elmswood Plantation in Clarendon County. He was also elected to the South Carolina House of Representatives during antebellum South Carolina.

With the outbreak of the American Civil War, Richardson enlisted in the Confederate Army in 1862 and was on the staff of Brigadier General James Cantey until the end of the war. After which, he was re-elected in 1865 to the South Carolina House of Representatives and later that year to the South Carolina Senate. Richardson was inactive in politics when Radical Republicans ruled the state during Reconstruction, but returned in 1880 on the Democratic ticket running unopposed for state Treasurer.

In 1886, Clarendon County Democrats endorsed Richardson in his candidacy for governor. His nomination proceeded forward to the state Democratic convention, where Lt. Gov. John Calhoun Sheppard, who had the backing of Benjamin Tillman,



opposed him. The recently formed Farmers' Association had a major influence in the nomination and backed Richardson despite an attempt by Tillman to force them to support Sheppard. Richardson won the nomination on the third ballot and went on to win the gubernatorial election of 1886 to become the 83rd governor of South Carolina.

Again opposed by Tillman for the gubernatorial election of 1888, Richardson managed to win the Democratic nomination for a second term as governor with the support of 60 percent of the delegates and ran unopposed in the general election that fall. During his time as governor, agitation from the farmers of the state for reforms increased, leading to the foundation of Clemson College in 1889 and the political rise of Ben Tillman.

On July 6, 1899, Richardson died in Columbia and was buried at Old Quaker Cemetery in Camden.

Ted Morton said: "The ceremony Saturday made for a great day for SCSSAR — and can serve as a good dress rehearsal for others to follow. You took the lead and gave birth to a whole idea of a Grave Marking for the Founders of SCSSAR. The religious element conducted by Richard Crozier, added a splendid, well-executed touch to the ceremony — giving it a ritual element beyond just a prayer!"

As you walked into the Quaker Cemetery, the aged tombstones and inscriptions seemed to say: "You are entering a world of hallowed ground. Here peacefully lie some of the first Americans of your kind. Protect and preserve the country they created, and for which they sacrificed, fought and died."

The Godfrey Dreher Chapter showed their respects by having the largest chapter Compatriot member attendance (10 members, one third of the Chapter) of any of the SCSSAR chapters attending the event.

Our Chapter contingent was led by Robert Escue, Chapter Genealogist and wreath presenter; Nelson McLeod, Chapter Historian and event organizer; and President Woody Carothers. Our Chapter Ladies Auxiliary and the DAR were represented by Deborah Blanpied.

Additional Compatriot attendees included Buddy Witherspoon, ROTC Awards Chairman; Compatriot Gary Blanpied, as well as Color Guardsmen Fred Morrison Sr., Fred Morrison Jr., Don Jones and Bill Wilson.

The Godfrey Dreher Chapter Uniformed Militia doubled in size, at this event, with Fred Morrison Sr. and Fred Morrison Jr. joining our Band of Brothers. With these two stalwart comrades joining the ranks, our new militia motto will be "Fear the Dreher."

239th anniversary Battle of King's Mountain

The Battle of Kings Mountain was a decisive battle between Patriot and Loyalist militias in the Southern campaign of the Revolution. The battle took place Oct. 7, 1780, nine miles south of the present-day town of Kings Mountain, North Carolina, in rural York County, South Carolina, where the Patriot militia defeated the Loyalist militia commanded by British Major Patrick Ferguson of the 71st Foot.

Major Ferguson's task was to march to the old Tryon County area, raise and organize Loyalist units from the Tory population of the Carolina Backcountry, and protect the left flank of Gen. Charles Cornwallis' main body at Charlotte, North Carolina.

North Carolina Patriot militia leaders Isaac Shelby and John Sevier, from the Washington District (now present day northeast Tennessee), met and agreed to lead their militiamen against him. Patriot leaders also sent word to a Virginia militia leader, William Campbell, asking him to join them. Campbell called on Benjamin Cleveland to bring his Wilkes County, North Carolina, militia to the rendezvous.

The detachments of Shelby, Sevier and Campbell were met by 160 North Carolina militiamen led by Charles McDowell and his brother Joseph. Campbell's cousin, Arthur Campbell, brought 200 more Virginians. About 1,100 volunteers from southwest Virginia and today's northeast Tennessee, known as the Overmountain Men because they had settled into the wilderness west of the Appalachian Mountains ridgeline, mustered at the rendezvous on Sept. 25, 1780, at Sycamore Shoals near the modern city of Elizabethton, Tennessee.

The Patriot militia put 900 men on horseback and rode for Kings Mountain. They arrived on Oct. 7 and immediately surrounded the ridge and attacked.

The battle began about 3 p.m., when the 900 Patriots (including John Crockett, father of Davy Crockett), approached the steep base of the western ridge. The Patriots caught the Loyalists by surprise. Firing was difficult for the Loyalists, since the Patriots constantly moved and used cover and concealment. Furthermore, the downhill angle of the hill caused the Loyalists to overshoot.

Ferguson was shot dead from his horse. When the rebels found his corpse they counted seven bullet wounds. Seeing their leader fall, all of the Loyalists began to sur-

render. Loyalist Captain Abraham DePeyster, in command after Ferguson was killed, sent out an emissary with a white flag, asking for quarter.

Eager to avenge the Waxhaw Massacre, where Banastre Tarleton's men had killed a sizable number of Abraham Buford's Continental soldiers after the latter had surrendered, some rebels did not initially want to take prisoners, while others were seemingly unaware that the Loyalists had surrendered.

The Patriots rejected DePeyster's white flag and continued firing, many of them shouting, "Give 'em Tarleton's Quarter!" and "Give them Buford's play!" After a few more minutes of bloodletting in which a significant number of the surrendering Loyalists were killed, DePeyster sent out a second white flag and a few rebel offi-

cers, including Campbell and Sevier, ran forward and took control by ordering their men to cease fire, giving quarter to around 700 Loyalists.

The Battle of Kings Mountain lasted 65 minutes. The Loyalists suffered 290 killed, 163 wounded and 668 taken prisoner. The Patriot militia suffered 29 killed and 58 wounded. The Patriots had to move out quickly for fear that Cornwallis would advance to meet them. Loyalist prisoners well enough to walk were herded to camps several miles from the battlefield. The dead were buried in shallow graves and wounded were left on the field. Ferguson's corpse was later reported to have been mangled and wrapped in oxhide before burial. Both victors and vanquished came near to starva-

tion on the march due to a lack of supplies in the hastily organized Patriot army.

Kings Mountain was a pivotal moment in the history of the American Revolution. Coming after a series of disasters and humiliations in the Carolinas—the fall of Charleston and capture of the American army there, the destruction of another American army at the Battle of Camden, the Waxhaws Massacre—the surprising, decisive victory at Kings Mountain was a great boost to Patriot morale. The Tories of the Carolina Back Country were broken as a military force.

In *The Winning of the West*, Theodore Roosevelt wrote of Kings Mountain, "This brilliant victory marked the turning point of the American Revolution."

Thomas Jefferson called it, "The turn of the tide of success"

Herbert Hoover said in an address at Kings Mountain, "This is a place of inspiring memories. Here less than a thousand men, inspired by the urge of freedom, defeated a superior force intrenched in this strategic position. This small band of Patriots turned back a dangerous invasion well designed to separate and dismember the united Colonies. It was a little army and a little battle, but it was of mighty portent. History has done scant justice to its significance, which rightly should place it beside Lexington, Bunker Hill, Trenton and Yorktown."

In 1931, the U.S Congress created the Kings Mountain National Military Park on the site of the battle. The park headquarters is in Blacksburg, South Carolina, and hosts hundreds of thousands of people each year.

THANKSGIVING DAY 1789 BY THE PRESIDENT OF THE UNITED STATES OF AMERICA - A PROCLAMATION

Whereas it is the duty of all Nations to acknowledge the providence of almighty God, to obey his will, to be grateful for his benefits, and humbly to implore his protection and favor - and Whereas both Houses of Congress have by their joint Committee requested me "to recommend to the People of the United States a day of public thanksgiving and prayer to be observed by acknowledging with grateful hearts the many signal favors of Almighty God, especially by affording them an opportunity peaceably to establish a form of government for their safety and happiness."

Now therefore I do recommend and assign Thursday the 26th day of November next to be devoted by the People of these States to the service of that great and glorious Being, who is the beneficent Author of all the good that was, that is, or that will be – That we may then all unite in rendering unto him our sincere and humble thanks – for his kind care and protection of the People of this country previous to their becoming a Nation – for the signal and manifold mercies, and the favorable interpositions of his providence, which we experienced in the course and conclusion of the late war –for the great degree of tranquillity, union, and plenty, which we have since enjoyed....

Given under my hand at the City of New York the third day of October in the year of our Lord 1789. GO. WASHINGTON.

Bylaw VII — Administration of the State Society

§10: Nominating — The committee shall consist of seven (7) members of which three (3) shall be elected by the Board of Governors at the October meeting and four (4) appointed by the State President such that each region of the state shall have at least one (1) representative. The committee shall elect its own chairman. The State Secretary shall serve as an advisor to the committee but may be eligible for election to or appointment as a voting member.

The committee shall produce a slate of officers to be presented to the Board of Governors for recommendation to the Annual Meeting of the Society. It is the duty of the committee to determine the eligibility of all those nominated for State Society offices.





How to submit items to The Palmetto Patriot

Here are some pointers.

Keep articles as short as possible while still telling the story. Send articles in Microsoft Word format to Tom.Hanson@HansonCommunications.org

Send digital photographs as attachments and not embedded into the Word document.

Make sure you images are high resolution, at least 200 DPI, and that no time or date stamps appear in the images.

Limit the number of photographs to those you would like most to appear in the publication.

In group shots, have participants drop their hands to their sides to avoid fig leaf poses.

When taking photos at meetings, get as close to the speaker as possible, and avoid shooting the backs of audience heads.

From Eric Barnhill, Gen. Andrew Pickens Chapter: Fill the frame with the subject, unless you are trying to capture a large area (monument, battlefield). Better to get head shots than feet shots. Choose your background carefully. Often it just takes a minute to look around and find a more appropriate background. Watch your lighting. Better to have subjects face the lights (sun for outdoor shots) and be careful of indoor lights, your camera may set the exposure for lights if they are in the shots. Articles are always more interesting when pictures accompany them. Take lots of digital pictures and choose the ones that best capture the subject. Check your spelling, spell check sometimes makes words you don't want.

SCSSAR Education Awards 2019

General:

- 1. The Winner in each category must be an adult non-SAR member who works in South Carolina and has an intrinsic association with the people of the State of South Carolina.
- 2. Each SCSSAR Chapter may nominate one chapter winner in each category. We encourage some sort of award at the chapter level, to be determined by that chapter. To avoid limitations on creative teaching, these criteria are deliberately vague.
- 3. The judging of all State Level awards will be conducted by the SCSSAR Education Committee and their decisions are final.
- 4. Nominations for Elementary School, Middle School and High School awards are due to the Education Committee by Dec. 31 of each year.
- 5. The Teachers must follow the guidelines and procedures listed at www.sar.org/ education/youth-contests-awards/american-history-teacher-award the Tom and Betty Lawrence Award, with the deadline of all completed applications due to the SCSSAR Education Committee by Dec. 14 of each year. (National Deadline)
- 6. The specifics of the prizes for the following year will be announced at the January meeting of the SCSSAR Board of Governors. Each level of education will be of equal value and prestige.
- 7. The winning entries will be announced and the prizes presented at the Annual SCSSAR Awards Luncheon during the annual meeting of the SCSSAR. It is expected that the nominating chapter will also recognize the recipient and their spouse or significant other at an appropriate meeting of the chapter.
- 8. The Elementary, Middle and High School nominees must teach in either private, parochial or public schools in South Carolina.
- 9. The criterion for each award is that the candidate should excel both creatively and effectively at teaching American Patriotism in the context of the American Revolution in South Carolina.

Categories:

- 1. Elementary: Teachers of Grades K-5, regardless of title or courses taught.
- 2. Middle: Teachers of Grades 6-8, regardless of title or courses taught.
- 3. High School: Teacher of Grades 9-12, regardless of title or courses taught.

Dr. George Mosse Chapter makes awards at two meetings

In the second half of the year, two monthly meetings were held Oct. 3 and Nov. 6.

Both meetings included a continuation of awards: The NROTC Award was presented to Cadet Daniel Ruiz, a junior at Hilton Head High School. The Eagle Scout Award was presented to Jack Lopko, Troop 245 at Hilton Head Island First Presbyterian Church. Each recipient received an SAR Certificate (Patch for Eagle Scout) and a Chapter check for \$100.

At both meetings Service Awards were presented and continued for those not available. This year, the Dr. George Mosse Chapter presented 20 awards for members with years of continued service. The collection included 11 Five Year, one 10 Year, two 15 Year, two 20 Year, one 25, one 30 Year, one 25 Year and one 45 Years.

Palmer Jones (47 years) delighted us with his historical account, living in Baltimore before moving to Hilton Head Island, starting the John Paul Jones Chapter. When he arrived in Hilton Head, the closest chapter was Savannah, so he and two others met at his house in 1983 and formed the Dr. George Mosse Chapter.

Next year, 2020, the Dr. George Mosse Chapter has already identified 17 members to receive Service Awards.

Note: this exercise is an amazing benefit to draw a larger attendance and reward members.

Also at both meetings, the Dr. George Mosse Chapter inducted nine new members. Chapter Registrar Art Ryan and Chapter Genealogist Sunni Bond should be recognized for their hard work in helping Dr. George Mosse grow. In addition to these new inductees, the Chapter has three transfers from Ohio and New York. We hope we can achieve a total of 10 new members, with a prospective member from Massachusetts.

The programs for the two months have focused on more fun and enjoyable topics. Meetings for February, March and April, have been reported in previous *Palmetto Patriot* issues. They were historical to the Revolutionary War.

In October we were treated to Dwight Pickett, an author and professional archaeologist with a masters degree in anthropology. Dwight, author of *Captain William Hilton and the Founding of Hilton Head Island*, was a re-enacted Captain William Hilton, who founded Hilton Head in Port

Royal Sound in 1663. The island began as a separate populated area on the fringe of English settlement in the late 17th century.

In November we were treated to Jim and Carol Alberto. Jim, author of *Daufuskie Daze*, described the ups and downs of teaching a group of children on Daufuskie Island from 1974 to 1983. They met Pat Conroy in 1973. Pat was a teacher for only months, followed by inconsistency in teachers assigned by Beaufort County on Daufuskie. Jim and Carol became the consistent and steady teaching for 22 boys and girls. Two of the students went on to college to graduate. 244th Anniversary Battle of Cane Brake

SIMPSONVILLE — The Col. Robert Anderson Chapter sponsored the 244th anniversary Commemoration of the Battle of the Great Cane Brake Dec. 7 at Historic Hopkins Farm in Simpsonville.

SCSSAR President Nat Kaminski opened the ceremonies with welcoming the 140 in attendance and gave an introduction stressing the importance of this short, but historically important skirmish. The Colors were presented by the SCSSAR Color

Guard, followed by the Pledge of Allegiance (State Historian Guy Higgins), the Salute to the South Carolina Flag (Bob Nations) and the SAR Pledge (Chapter Vice President Joe Glavitsch).

Chapter Chaplin Rev. John Vaughn led the invocation. Greetings and welcoming remarks were made by President Kaminski.

Chapter President John Satterthwaite gave a history of the Battle of the Great Cane Break as he introduced the keynote speaker, historian Durant Ashmore.

> Mr. Ashmore gave an in depth description of the participants and events leading up to, during and following the battle.

> President Kaminski introduced 14 DAR, SAR, CAR and SR members and state society representatives as they presented wreaths and gave their respects to our Patriot ancestors.

President Kaminski then led the SAR Recessional. Rev. Vaughn led the Benediction, which was followed by a rifle volley, as members of

the SCSSAR Color Guard concluded this year's program.

Period presentations were made by Colonial craftsmen including a tomahawk thrower, shingle maker and displays of weapons and other items of interest. Numerous area middle school students (including 17 from Mauldin Middle School), their parents and teachers interacted with and expressed their delight in the experience.

After the event, Durant Ashmore led a group of attendees through the woods and swamp to what is considered the original battle site and filled participants in on more interesting stories of the event and area.

Dignitaries in attendance were Nat Kaminski, SCSSAR President; SCSCAR President Joseph Smith; SCSSAR Historian Guy Higgins; SCSSAR Recording Secretary Jonathan Kiser; Dan Woodruff, Piedmont Area SCSSAR Vice President; and Tom Weidner, President of the South Carolina Society Sons of the Revolution. Several other State and Chapter officers were also present.

NOTE: The temperatures were in the 20s for our ancestors who fought that day in clothing not suited for the sub-freezing temperatures. More suffered permanent injuries from the weather and the walk back to Charles Town, than they did in the battle itself. We can't begin to imagine the sacrifices they made for America's freedom.

Remembering Cane Brake

With the coming of the American Revolution, the Patriot government in Charles Town was opposed by a large concentration of "King's men" in the Upcountry. Both sides recognized the need to cultivate the friendship of the Cherokees in a nearly lawless area of the state, and both sides promised to provide the Indians with ammunition for hunting.

In October 1775, the Patriot Council of Safety in Charles Town sent 1,000 pounds of powder and 2,000 pounds of lead to the Indians, but a force of about 500 Loyalists under the command of Captain Patrick Cunningham intercepted and commandeered the wagon train.

Following an unsuccessful attempt to retake the munitions, the Charles Town

Patriot leaders endeavored to break the strength of Upcountry Loyalism by raising an overwhelming force of militiamen under the command of Col. Richard Richardson. Heavily outnumbered, the King's men fell back toward the Piedmont. By late December, Richardson had perhaps as many as 5,000 troops under his command and had captured the major Loyalist leaders.

On Dec. 21, Richardson ordered 1,300 men under Col. William "Danger" Thomson to pursue the Loyalists into Indian territory. Thomson marched 25 miles through the night to a camp where Loyalists had been sheltering from cold rain and snow flurries in a Brake of Canes. Because the ground was wet and the Loyalists had been warming themselves by burning cane stalks that popped and crackled, Thomson's men nearly managed to surround the camp before being discovered as they attacked at dawn.

Cunningham escaped on an unsaddled horse and without his breeches, shouting for every man "to shift for himself." The Patriots recaptured the munitions intended for the Cherokees, and they took 130 prisoners, forcing them to sign a document promising not to take up arms again.

One Patriot militiaman was wounded. Only five or six Loyalists were killed, though Thomson had to restrain his men from harming the prisoners, some of whom were sent off to Charles Town in chains.

Despite the Patriot success, an unusual, heavy snowstorm occurred the following day, which caused considerable suffering among the militiamen, who had been called to duty on short notice with inadequate clothing and without tents. Some were permanently injured by exposure and frostbite. Thereafter the events surrounding Cane Brake became known as the Snow Campaign. (From Wikipedia.org)






